1. The name of the Corporation is Alternatives for Battered Women, Inc.
2. The Certificate of Incorporation for the Corporation was filed with the Secretary of State on December 1, 1977, under the name of Alternatives for Battered Women, Inc.
3. The Corporation is a corporation as defined in sub paragraph (a) (5) of section 102 (Definitions).
4. Paragraph 1. of the Certificate of Incorporation is hereby amended in its entirety as follows:
