Subject: Establishment of a Trust Fund Entitled "Monroe County Division of Social Services Childcare Fund"

Honorable Legislators:

We recommend that Your Honorable Body authorize the establishment of a trust fund entitled "Monroe County Division of Social Services Childcare Fund" and accept donations into the newly created fund.

As County leaders, we have made providing affordable childcare a top priority, even during tough fiscal times. Our subsidized childcare program is important, because it empowers parents to secure a brighter future for themselves and their families. Monroe County's annual commitment is nearly four times greater than any other county outside of New York City, despite the fact that the cost of childcare per child has increased by over 50% since 2004.

With mandated spending accounting for 83% of Monroe County's 2014 Budget, it is clear that government simply can't do it alone. Instead, we have developed a collaborative solution to capitalize on our community's unparalleled generosity and provide additional funding for childcare, all without impacting taxpayers.


The "Monroe County DSS Childcare Fund" will accept donations from residents, advocates, and stakeholders in our community who have called for additional 2014 funding for childcare. All proceeds will be 100% dedicated to providing additional childcare subsidies and every \$6,200 raised ensures another local child is eligible for full-year benefits.




No net County support is required in the current Monroe County budget.


We recommend that this matter receive favorable action by Your Honorable Body.


