Honorable Legislators:

I recommend that Your Honorable Body approve an amendment to the Collective Bargaining Agreement between the Monroe County Executive and the Federation of Social Workers, IUE-CWA 381, increasing the 2022 salary schedule by 2.5%, effective Pay Period 7.

The estimated costs of this referral for 2022 is \$891,087.

The specific legislative actions required are:

1. Approve an amendment to the Collective Bargaining Agreement between the Monroe County Executive and the Federation of Social Workers, IUE-CWA 381, to increase the 2022 salary schedule by 2.5%, effective Pay Period 7.
2. Amend the 2022 Budget Salary Schedule to reflect the amendment to the Collective Bargaining Agreement with the Federation of Social Workers, IUE-CWA 381.

This action is a type II Action pursuant to 6 NYCRR § 617.5(c)(28) ("collective bargaining activities") and is not subject to further review under the State Environmental Quality Review Act.

Funding for this amendment is included in the 2022 operating budget. No additional net County support is required in the current Monroe County budget.
