Re: Memorializing the New York State Legislature and Governor Cuomo to Continue to Increase Funding for the Safe Harbour Initiative in Monroe County in Future State Budgets

Honorable Legislators,

Protecting the well-being of children is a top priority in Monroe County. Children should never be subject to abuse or sex trafficking. Since 2012, Monroe County has been receiving grant money from New York State to fund the Safe Harbour Initiative. Monroe County contracts with the Center for Youth for this program and has had tremendous results. The program seeks children who are victims of sex trafficking and provides them with a safe place and services. By going out into the community to reach out to victims of trafficking, the Center for Youth has been able to find and assist more children who are at risk and need help. In 2016, the Safe Harbour Initiative was able to assist 266 victims.

Unfortunately, there is an ominous estimate for where this program will be in the future. Monroe County's funding this year has been decreased by New York State from the previous five years we have received funding. Also, there is no estimated funding for Monroe County in next year's state budget, which will make maintaining and continuing this initiative with the same success, very difficult. While Monroe County will continue assisting trafficked children, doing so without this funding will be very challenging. Without funding from the State, it will be difficult to identify trafficked children, which means only those victims who reach out may be identified. As can be imagined, victims of trafficking may not think to reach out to Monroe County or the Center for Youth and victims may go without services.

The safety of children should continue to be important statewide. Monroe County has proven to be most successful in helping children and young adults through the Safe Harbour Initiative. Monroe County should continue to receive funding that reflects this success. New York State should recognize the accomplishments of Monroe County and the Center for Youth, as well as the importance of State funded grants in the development of this program. Therefore, I urge you to join me in asking New York State to continue to include funding for the Safe Harbour Initiative in Monroe County in future state budgets.

Honorable Legislators:

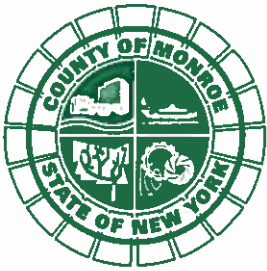

Unified Sports Teams consist of student athletes with and without mental or physical disabilities. This is done in an effort to give those who participate in the league a feeling of competition.

Currently all funding for unified sports comes from either the Department of Education or the Special Olympics. New York State Senators Robert Ortt and Rich Funke have recently called upon the New York State Legislature to propose funding in the New York State Budget in the amount of \$425,000 to support the creation of Unified Sports Programs throughout New York State. Sections II and V already have begun successful Unified Sports Programs, these leagues support the inclusion of all types of student athletes and I believe they should be promoted throughout the New York State Public High School Athletic Association.

RE: Memorializing the New York State Legislature and Governor Andrew Cuomo to Invest \$100 Million in Additional Funding for Child Care Subsidies, thereby Increasing the Number of Eligible Children Served

Honorable Legislators,

Quality child care improves children's social skills, lays a foundation for learning, and increases academic outcomes. Monroe County's poverty rate is above both the state and national average, and 73% of children in Monroe County live in a family where all available parents work. Not only does quality child care help children grow developmentally, it creates a stabilizing effect allowing parents to both enter and remain in the work force. Parents are less likely to miss work, more likely to provide a stable home environment and more likely to escape the oppressive cycle of poverty.


Childcare subsidies currently serve only 22% of eligible working families in Monroe County, meaning many children may be improperly cared for at a non-licensed facility, or left unsupervised while parents work. Quality and affordable childcare must remain a budget priority. Working families who need child care to remain working, are also taxpayers. New York State has a responsibility to oversee the well-being and safety of our most vulnerable citizens, while ensuring that parents remain employed.

Therefore, I ask you to join us in requesting Governor Andrew Cuomo invest \$100 million in additional funding for Child Care subsidies, thereby increasing the number of children who are eligible to be served in New York State and Monroe County.





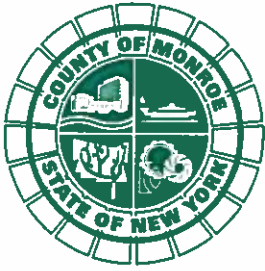

Honorable Legislators,

In the last decade, New York has lost 304,900 manufacturing jobs. Nationally, U.S. workers and the domestic manufacturing economy have been devastated by the growth of the U.S. trade deficit with China since their entry to the World Trade Organization in 2001. Between 2001 and 2011, 2.7 million U.S. jobs were lost or displaced. New York alone lost 158,800 jobs due to this trend.

The purpose of New York State Bills A02086 and S04073 is to ensure that American produced materials are given preference on state sponsored procurements. The production of iron, steel and manufactured products provides jobs and family income to many individuals in New York State and, in turn, jobs and family incomes of millions of people in the United States. Employers and employees of public works in this state generate substantial revenues that New York State, its subdivisions and authorities will use to modernize our public works and infrastructure system.

New York State's procurement policies should reflect this state's, as well as the country's principles, ensuring that the products of those companies and workers who abide by our workplace safety and environmental laws and regulations are rewarded with a preference in government contracting. New Yorkers, like all Americans, expect that their tax dollars will be reinvested in taxpaying businesses and workers that produce goods in New York and in the U.S. Many states already have similar laws that create a procurement preference for American-made goods when they are available in a sufficient quality and quantity, and are competitively priced in the global marketplace. The preference proposed under this legislation allows for a waiver if goods are unavailable from domestic sources, or the cost of the goods from domestic sources is unreasonable.

This legislation will harmonize existing New York state procurement statutes, across the board, with the practices New York State agencies use when executing programs funded by federal grants. Therefore, I urge you to join us in asking the NYS Assembly and the NYS Senate to pass, and Governor Andrew Cuomo to sign, A02086 and S04073, the "New York State Buy American Act".





RE: Memorializing the New York State Senate to Pass, and Governor Andrew Cuomo to Sign, S.04121, an Act to Amend the Criminal Procedure Law, the Executive Law, the Family Court Act and the Penal Law, in relation to Raising the Age of Criminal Responsibility; and to Repeal certain Provisions of the Criminal Procedure Law

This bill amends and enacts various provisions of law to raise the age of adult criminal responsibility from sixteen to eighteen so that youth who are charged with a crime may be treated in a more age appropriate manner. These changes reflect the evidence that the current system has not been effective in deterring and preventing future crime.

Juvenile detention is expensive, however prosecuting and incarcerating young people in the adult system costs even more. Research by the Urban Institute presented to Connecticut policy makers indicated that for every dollar invested in moving young people from the adult system to the juvenile justice system, taxpayers saved \$3 in reduced crime and incarceration costs. Because of this research, the state of Connecticut raised the age of juvenile court jurisdiction to 18.

Family Court offers opportunities and resources to youth that adult prisons do not, and the rate of recidivism after serving time in an adult prison is much higher. For example, the cost of lost educational opportunities and a person's ability to work and pay taxes without relying on public assistance, is far greater than housing youth in adult prisons. In addition, there is evidence of the decreased likelihood that offenders housed in juvenile detention will commit a new offense in the future.

In the United States, only New York and North Carolina treat 16 and 17 year old as adults when charged with a crime. New York State Senate Bill 04121 would amend and enact various provisions to raise the age of adult criminal responsibility from sixteen to eighteen. It also maintains that youth, on a case by case basis, may be tried in adult criminal court when

circumstances warrant, such as in a particularly heinous and/or violent crime. Therefore, we urge you to join us in asking the New York State Senate to pass, and Governor Andrew Cuomo to Sign, S.04121, an Act to Amend the Criminal Procedure Law, the Executive Law, the Family Court Act and the Penal Law, in relation to Raising the Age of Criminal Responsibility; and to Repeal certain Provisions of the Criminal Procedure Law.



Subject: Authorize a Contract with Correctional Consulting, Inc. for Monitoring of Inmate Medical and Mental Health Services

Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of Sheriff Patrick M. O'Flynn.

I recommend that Your Honorable Body authorize a contract with Correctional Consulting, Inc. (CCI), in an amount not to exceed \$50,000, for the review, auditing and monitoring of contract performance by the Sheriff's inmate medical and mental health services provider, and the provision of written reports and recommendations regarding the performance of the medical and mental health services provided to the inmates in the custody of the Sheriff, for the period of April 1, 2017 through March 31, 2018, with the option to renew for two (2) additional one-year periods, upon mutual consent of the parties, in an amount not to exceed \$50,000 per year.

Established in 2006, CCI provides contract monitoring of medical and mental health services in a jail or prison setting. For the past 10 years CCI has performed contract monitoring services for the Monroe County Sheriff as part of its Inmate Medical and Mental Health Contract.

A Request for Qualifications was issued for this service with Correctional Consulting, Inc. selected as the most qualified to provide this service.

The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract, and any amendments thereto with, Correctional Consulting, Inc., 9087 NW 21st Street, Coral Springs, Florida 33071, in an amount not to exceed \$50,000, for the review, auditing and monitoring of contract performance by the Sheriff's inmate medical and mental health services provider, and the provision of written reports and recommendations regarding the performance of the medical and mental health services provided to the inmates in the custody of the Sheriff, for the period of April 1, 2017 through March 31, 2018, with the option to renew for two (2) additional one-year periods upon the mutual consent of the parties, in an amount not to exceed \$50,000 per year.

This matter is being referred to Your Honorable Body at the request of Sheriff Patrick M. O'Flynn.

I recommend that Your Honorable Body authorize an intermunicipal agreement with the Spencerport Central School District for general security assistance and crowd control at the 2017 Junior Prom and Senior Ball events, at a rate of \$76.75 per hour, for an estimated amount due of \$690.75, subject to the upward or downward pro rata departure depending on the duration of the events, for the period of May 13, 2017 through June 3, 2017.

The specific legislative action required is to authorize the County Executive, or her designee, to execute an intermunicipal agreement, and any amendments thereto, with the Spencerport Central School District, for general security assistance and crowd control at the 2017 Junior Prom and Senior Ball events, for the period of May 13, 2017 through June 3, 2017, at a rate of \$76.75 per hour, for an estimated amount due of \$690.75, subject to the upward or downward pro rata departure depending on the duration of the events.

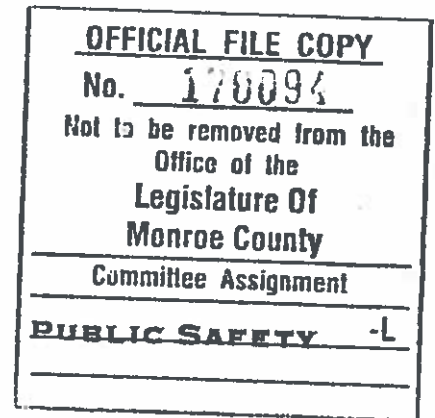

Subject: Approve and Adopt the Monroe County Hazard Mitigation Plan

Honorable Legislators:

I recommend that Your Honorable Body approve and adopt the Monroe County Hazard Mitigation Plan ("the Plan").

The Federal Disaster Mitigation Act of 2000 requires that all local governments have an approved disaster mitigation plan in place in order to be eligible for Federal Hazard Mitigation Grant Program project funding. Monroe County and all political subdivisions within the County opted to author a multi-jurisdiction plan and have actively participated in the design and writing of the Plan. Federal regulations implementing the Disaster Mitigation Act of 2000 (44 CFR Section 201.6(c)(5)) require that the Plan be formally adopted by each jurisdiction requesting approval of the Plan. Therefore, the County Legislature and all local government legislative bodies must approve and adopt the Plan. The Act requires that Disaster Mitigation Plans be revised on a 5-year cycle. The Plan replaces the existing Pre-Disaster Mitigation Plan.

The specific legislative actions required are:

1. Schedule and hold a public hearing on the Monroe County Hazard Mitigation Plan.
2. Approve and adopt the Monroe County Hazard Mitigation Plan.
3. Authorize the County Executive, or her designee, to submit the Monroe County Hazard Mitigation Plan to the New York State Division of Homeland Security & Emergency Services and the Federal Emergency Management Agency.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

The Plan will have no impact on the revenues or expenditures of the current Monroe County budget.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by Your Honorable Body.

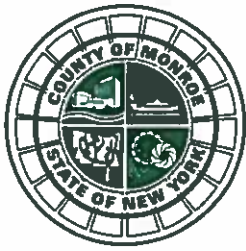

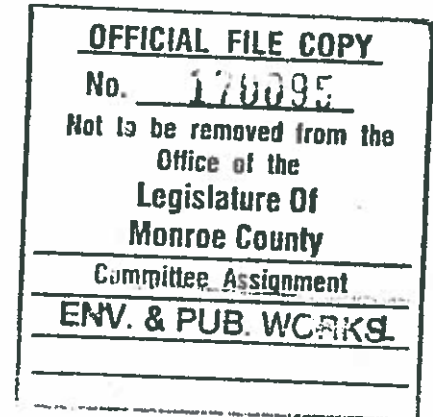

Honorable Legislators:

I recommend that Your Honorable Body authorize a contract with the New York State Department of Environmental Conservation for Monroe County to maintain custody and utilize an oil spill response trailer and equipment, for the period of March 14, 2017 through March 14, 2027.

This contract will help to enhance the availability of spill response resources in Monroe County that could be employed to mitigate a number of hazardous material based spill scenarios including those associated with a crude oil incident along the CSX rail corridor. This oil spill response trailer and equipment will be stored at Monroe County's Fleet Center on Paul Road, along with the County's supplemental hazardous materials response resources.

The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract, and any amendments thereto, with the New York State Department of Environmental Conservation, for Monroe County to maintain custody and utilize an oil spill response trailer and equipment, for the period of March 14, 2017 through March 14, 2027.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

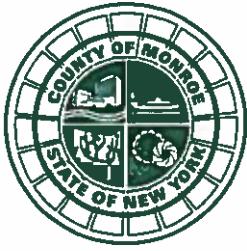

Subject: Amend the 2017 Capital Budget and Bond Resolution 319 of 2015 to Provide an Increase in Funding and Authorize a Contract with CHA Consulting, Inc. for Design Services for the Rehabilitate and Reconstruct Existing Aircraft Aprons Project at the Greater Rochester International Airport

Honorable Legislators:

I recommend that Your Honorable Body amend the 2017 Capital Budget and Bond Resolution 319 of 2015 to provide an increase in funding and authorize a contract with CHA Consulting, Inc., in the amount of \$90,000, for design services, for the Rehabilitate and Reconstruct Existing Aircraft Aprons Project at the Greater Rochester International Airport.

The scope of the project will deliver improved aircraft safety on the General Aviation side of the airfield. The project developed with the Federal Aviation Administration during 2017, accomplishes this goal with revised pavement geometry, drainage systems, signage and related physical improvements to the airport. The funding being offered by the FAA to complete this project and accomplish project goals is greater than currently available in the existing capital account. This increase in the capital account will allow the airport to deliver the desired project without constraint on the use of the funding available from the FAA. The total estimated program cost is now \$6,000,000.

This project will be funded by a Federal Aviation Administration grant of 90%, a New York State Department of Transportation grant of 5%, and a local share of 5%.

The Department of Aviation recommends authorization of a contract with CHA Consulting, Inc., a designated airport consultant per Resolution 18 of 2015, to provide design services for the Rehabilitate and Reconstruct Existing Aircraft Aprons Project in the amount of \$90,000.

The specific legislative actions required are:

1. Amend the 2017 Capital Budget to increase funding for the Rehabilitate and Reconstruct Existing Aircraft Aprons Project at the Greater Rochester International Airport, in the amount of \$1,600,000 from \$4,400,000 to \$6,000,000, for a total project authorization of \$6,000,000.
2. Amend Bond Resolution 319 of 2015 to increase financing for the Rehabilitate and Reconstruct Existing Aircraft Aprons Project at the Greater Rochester International Airport, capital fund 1623, in the amount of \$1,600,000 from \$4,400,000 to \$6,000,000, for a total project authorization of \$6,000,000.

3. Authorize the County Executive, or her designee, to execute a contract with CHA Consulting, Inc., 16 Main Street West, Suite 830, Rochester, New York 14614, for design services, for the Rehabilitate and Reconstruct Existing Aircraft Aprons Project at the Greater Rochester International Airport, in the amount of \$90,000, along with any amendments necessary to complete the project within the total capital fund(s) appropriation.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.


Funding for this project, consistent with authorized uses, will be available in capital fund 1623 once the additional financing authorization requested herein is approved and in any capital fund(s) created for the same intended purpose. The funding for this project will be provided by the Monroe County Airport Authority from Airport generated revenues. No net County support is required in the current Monroe County budget.

The records in the Office of the Monroe County Treasury have indicated that neither CHA Consulting, Inc., nor any of its principal officers, owe any delinquent Monroe County property taxes. The principal officers of the firm are:

Subject: Amend the 2017 Capital Budget and Bond Resolution 14 of 2017 to Provide an Increase in Funding for the North Ramp Improvements Project at the Greater Rochester International Airport and Authorize a Contract with CHA Consulting, Inc. for Design Services

Honorable Legislators:

I recommend that Your Honorable Body amend the 2017 Capital Budget and Bond Resolution 14 of 2017 to provide an increase in funding for the North Ramp Improvements Project at the Greater Rochester International Airport, and authorize a contract with CHA Consulting, Inc., in the amount of \$160,000, for design services.

The current Airport Pavement Management Update Report has identified areas of the Terminal Apron which required major work to maintain a safe surface for aircraft movement around the Terminal. The aircraft pavement area between the concourses shows deterioration of the concrete pavement that is over 30 years old. Drainage system updates to manage deicing fluid runoff will also be implemented. The North Ramp Improvements Project will include engineering investigations to more accurately define the cause and extent of the deterioration and review cost effective rehabilitation strategies during the design of the improvements. The total estimated project cost is now \$11,000,000.

This project will be funded by a Federal Aviation Administration grant of 90%, a New York State Department of Transportation grant of 5%, and a local share of 5%.

The Department of Aviation recommends authorization of a contract with CHA Consulting, Inc., a designated airport consultant per Resolution 18 of 2015, to provide design services for the North Ramp Improvements Project in the amount of \$160,000.

The specific legislative actions required are:

1. Amend the 2017 Capital Budget to increase funding for the North Ramp Improvements Project at the Greater Rochester International Airport, in the amount of \$4,000,000 from \$7,000,000 to \$11,000,000, for a total project authorization of \$11,000,000.
2. Amend Bond Resolution 14 of 2017 to increase financing for the North Ramp Improvements Project at the Greater Rochester International Airport, capital fund 1767, in the amount of \$4,000,000 from \$7,000,000 to \$11,000,000, for a total project authorization of \$11,000,000.

3. Authorize the County Executive, or her designee, to execute a contract with CHA Consulting, Inc., 16 Main Street West, Suite 830, Rochester, New York 14614, for design services, for the North Ramp Improvements Project at the Greater Rochester International Airport, in the amount of \$160,000, along with any amendments necessary to complete the project within the total capital fund(s) appropriation.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.


Funding for this project, consistent with authorized uses, will be available in capital fund 1767 once the additional financing authorization requested herein is approved and in any capital fund(s) created for the same intended purpose. The funding for this project will be provided by the Monroe County Airport Authority from Airport generated revenues. No additional net County support is required in the current Monroe County budget.

The records in the Office of the Monroe County Treasury have indicated that neither CHA Consulting, Inc., nor any of its principal officers, owe any delinquent Monroe County property taxes. The principal officers of the firm are:
