Honorable Legislators:

Thousands of men and women throughout the United States have left high school and the comfort of their home to serve in the armed forces when our nation was engaged in war or conflict. Their service and sacrifice have ensured our freedom and have shaped our magnificent history. After returning home, many veterans are unable to complete their high school education for various reasons, but have become active members of our communities throughout their lives.

“Operation Recognition” is a state program that allows World War II, Korean, and Vietnam veterans who left high school early to receive their high school diploma. This legislation has passed the New York State Senate with unanimous support and has been sent to the New York State Assembly for consideration.

These men and women courageously served the United States when we needed them and many left before they could earn their high school diploma. Offering an opportunity for all veterans to apply for a high school diploma is a way to show our appreciation for their service and sacrifice. They are most definitely deserving of a high school education due to the experience they gained while protecting us and serving their country.

Therefore, we urge you to join us in calling on the New York State Assembly to pass, and Governor Andrew Cuomo to sign, S6292, an act to amend the education law, to allow all honorably discharged veterans the opportunity to receive their high school diploma.

**RE: Memorializing the United States Senate to Oppose HR 620, the
Americans with Disabilities Act (ADA) Education and Reform Act**

Honorable Legislators,

When passed in 1990, the American with Disabilities Act (ADA) was the first comprehensive civil rights legislation aimed at ending discrimination against Americans with disabilities. The ADA guarantees that people with disabilities have the same opportunities as all Americans to participate in the mainstream of our communities including the ability to enjoy employment opportunities, to purchase goods and services, and to participate in state and local government programs and services.


Since then, extraordinary progress has been made to improve access for all Americans. While there is still work to do, there are efforts in Congress to weaken the ADA. Once such piece of legislation, named the 'ADA Education and Reform Act,' would create significant obstacles for people with disabilities to enforce their rights under Title III of the ADA to access public accommodations and would impede their ability to engage in daily activities and participate in the mainstream of society. Rather, the burden of protecting the right to access a public place is shifted to the person with the disability, who first has to be denied access; then must determine that violations of the law have occurred; then must provide the business with specific notice of which provisions of the law were violated and when; and finally, the aggrieved person with the disability must afford the business a lengthy period to correct the problem. This cumbersome process violates the spirit of the original act and will make life more difficult for many of our fellow Americans.

Therefore, we ask you to join us in memorializing the United States Senate to oppose HR 620, the ADA Education and Reform Act.



Honorable Legislators:


In 2017 the Centers for Disease Control and Prevention warned that life expectancy in the United States has dropped for the second year in a row with the biggest reason attributed to drug overdoses. In the U.S., 115 Americans die *every day* from drug overdoses. The opioid crisis is a critical public health emergency and we need to begin addressing it as such. During the 1980s and 1990s, deaths from HIV/AIDS grew rapidly and our medical systems were not equipped to provide effective care. It was not until the Ryan White Comprehensive AIDS Resources Emergency Act was passed by Congress that the funding needed to help states and local governments fight this epidemic was provided.

This CARE Act is modeled directly on the Ryan White CARE Act, supporting local decision-making and federal research and recovery support services. It is estimated that the opioid crisis cost the nation more than \$500 billion in 2015, and the costs and deaths keep rising. In Monroe County alone, total drug overdose deaths between 2014 and 2016 were 345. The CARE Act would provide \$100 billion in federal funding over ten (10) years, including: \$4B per year to states; \$2.7B per year to the hardest hit counties and cities; \$1.8B per year for public health surveillance, biomedical research, and improved training for health professionals; \$1B per year to support expanded and innovative service delivery and \$500 million per year to expand access to the overdose reversal drug naloxone.

Under the CARE Act, New York State would receive an estimated \$102.7 million per year in state formula grants to fight substance abuse, with the opportunity to apply for additional

funding from a \$1.6 billion competitive grant program. Total CARE Act funding for Monroe County would be \$4,313,700 for the first year. Therefore, we ask you to join us in memorializing the Senate to pass S.2700, and the House of Representatives to introduce and pass a companion bill to, the Comprehensive Addiction Resources Emergency (CARE) Act.





Subject: 2018 Annual Action Plan for Housing and Community Development in Suburban Monroe County and Grant Submission to the U.S. Department of Housing and Urban Development

Honorable Legislators:

I recommend that Your Honorable Body approve Monroe County's 2018 Annual Action Plan for Housing and Community Development in Suburban Monroe County and Grant Submission to the U.S. Department of Housing and Urban Development (HUD) for the Community Development Block Grant (CDBG), Home Investment Partnerships Program (HOME) and Emergency Solutions Grants (ESG) programs.

Approval of this submission by HUD will provide the County with funding in the amount of \$3,116,444 for the period August 1, 2018 to July 31, 2019. This represents the combined total of funds for the CDBG Program in the amount of \$1,804,848; the HOME Program in the amount of \$1,162,797; and the ESG Program in the amount of \$148,799. This year's allocations represent a \$731,126 increase in grant allocations from HUD received last year. This is the 43rd year the County will receive this funding.

The CDBG, HOME and ESG programs have been designed to carry out neighborhood projects, Americans with Disabilities Act (ADA) improvements to public facilities, community services, economic development activities, housing activities, and homeless services. Pursuant to HUD regulations, these programs must principally benefit low to moderate-income persons, the elderly and persons with special needs who live in the towns and villages that participate in the Monroe County Community Development Consortium.

Members of the Consortium and community services agencies apply to the County to receive grants for projects, which are listed in the 2018 Annual Action Plan.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to submit the 2018 Annual Action Plan to the United States Department of Housing and Urban Development (HUD) and to provide such additional information as may be required by HUD for the Community Development Block Grant, Home Investment Partnerships Program and Emergency Solutions Grants programs.
2. Authorize the County Executive, or her designee, to accept the grant funds in the amount of \$3,116,444 or such other amount as determined by the United States Department of Housing and Urban Development (HUD), subject to HUD approval of the submission.
3. Appropriate the sum of \$3,116,444 for grant funds, or such other amount as determined by the United States Department of Housing and Urban Development (HUD), and the sum of \$144,134, which is the estimated Program Income expected to be generated during the program year, into fund 9005; funds center 1501010000, Community Development Grants, contingent on HUD approval.


4. Authorize the County Executive, or her designee, to execute all contracts, including intermunicipal agreements, and any amendments thereto, that are necessary to carry out the administration of the Community Development Block Grant, Home Investment Partnerships Program and Emergency Solutions Grants programs.
5. Authorize the County Executive, or her designee, to execute all agreements, debt instruments, and other documents for each loan, grant, relending project or activity which may be approved under the United States Department of Housing and Urban Development (HUD) Section 108 Loan Guarantee Assistance program, pursuant to Section 168.00 of the Local Finance Law, and to accept, receive and reappropriate funds which are borrowed from HUD or any other party, and relend the same to qualified borrowers.
6. Authorize the County Executive, or her designee, to approve the use of contingency funds or funds reprogrammed from current or prior years pursuant to the United States Department of Housing and Urban Development regulations.
7. Authorize the County Executive, or her designee, to accept, receive and appropriate or reappropriate any funds which accrue to the Community Development Office in the form of program income for use in connection with programs offered or funded by the Community Development Office, which administers the grants. All such income shall be utilized in accordance with the United States Department of Housing and Urban Development regulations governing the use of program income.
8. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.
9. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify such program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law, and when applicable, the terms of any labor agreement affecting such positions.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

This grant is funded by the U.S. Department of Housing and Urban Development. No additional net County support is required in the current Monroe County budget.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by Your Honorable Body.

Subject: 2019-2024 Capital Improvement Program

Honorable Legislators:

I recommend that Your Honorable Body adopt the proposed 2019-2024 Capital Improvement Program as recommended by the Monroe County Planning Board. The proposed Capital Improvement Program is submitted to the County Legislature in accordance with Section C4-10 of Article IV and Section C5-7 of Article V of the Monroe County Charter.

This proposed program includes projects designed to address aging infrastructure while at the same time ensuring that Monroe County continues to grow and expand its job base and quality of life. Projects contained in the program are intended to improve and modernize public buildings, construct needed highway and bridge improvements, as well as continue investment in public safety, the Greater Rochester International Airport, the County park system, the Monroe County Library System, the Monroe Community Hospital, and Monroe Community College.

The 2019-2024 Capital Improvement Program is the result of a team effort involving the County Executive's Office, Departments of Planning and Development, Finance (Office of Management and Budget), Law, Transportation, Environmental Services (Engineering Division), and Information Services. In addition, the Monroe County Planning Board put in many hours in reviewing and recommending this program. I want to thank all of those involved in the preparation of this program for their hard work and dedication.

The specific legislative actions required are:

1. Fix a public hearing on the adoption of the proposed 2019-2024 Capital Improvement Program.

2. Direct the Clerk of the Legislature to publish legal notice of such public hearing at least once in one daily newspaper of general circulation in the County at least ten (10) days before the date set for the hearing.
3. Adopt the proposed 2019-2024 Capital Improvement Program, as submitted, in its entirety.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

The adoption of the proposed 2019-2024 Capital Improvement Program will have no impact on the revenues or expenditures of the current Monroe County budget.

Subject: Acceptance of the Alternatives to Incarceration Grant from the New York State Division of Criminal Justice Services for the Pretrial Program, Enhanced Pretrial Program, and Domicile Restriction Program

Honorable Legislators:

I recommend that Your Honorable Body accept the Alternatives to Incarceration (ATI) grant from the New York State Division of Criminal Justice Services, in the amount of \$319,097; allocated as \$165,901 for the Pretrial Program, \$102,645 for the Enhanced Pretrial Program, and \$50,551 for the Domicile Restriction Program, for the period of July 1, 2018 through June 30, 2019.

The goal of all ATI programs is to reduce recidivism, promote public safety, and enhance defendant/offender accountability through community corrections. Probation Officers and Pretrial Services Corporation staff interview defendants to determine if any ATI programs would be appropriate for the defendant.

The Pretrial Program provides universal screening for defendants arrested and detained in the Monroe County Jail. The program staff interview defendants, verify information given and communicate that information to the Court in order to assist a qualified defendant in obtaining release on his/her own recognizance in lieu of money bail or pre-trial detention. If the defendant is released to the program, he/she is monitored to ensure attendance at subsequent Court appearances.

The Enhanced Pretrial Program provides intensive monitoring of a defendant by an individual case manager. An additional treatment component may be required of the defendant. The Program team links defendants with treatment programs, monitors defendant progress, and makes recommendations to the court for adjustment/modification. Monitoring occurs through personal and telephone contacts and continues at least twice per week until case disposition.

The Domicile Restriction Program provides an alternative to incarceration by the use of electronic monitoring of offenders. The program includes traditional phone monitoring, Global Positioning System monitoring and alcohol sensing equipment for high-risk offenders. By placing offenders in this program, the County saves money, and the offender has the opportunity to continue their employment, schooling, and/or treatment and maintain familial ties, thereby reducing their chance of re-offending.

The two (2) pretrial programs will be provided by Pre-Trial Services Corporation of the Monroe County Bar Association. The Domicile Restriction Program will be administered by staff from the Monroe County Office of Probation - Community Corrections. This will be the twenty-sixth year that the County has received this grant. This year's funding represents the same amount as last year.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept a \$319,097 grant from, and to execute a contract and any amendments thereto with, the New York State Division of Criminal Justice Services, allocated as \$165,901 for the Pretrial Program, \$102,645 for the Enhanced Pretrial Program, and \$50,551 for the Domicile Restriction Program, for the period of July 1, 2018 through June 30, 2019.
2. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within grant guidelines to meet contractual commitments.
3. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law, and when applicable, the terms of any labor agreement affecting such positions.



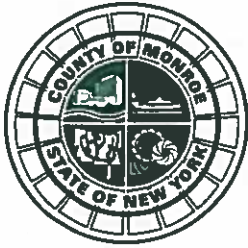

Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of Sheriff Todd K. Baxter.

I recommend that Your Honorable Body authorize an intermunicipal agreement with Monroe #1 Board of Cooperative Educational Services ("BOCES #1"), in the amount of \$96,424, for reimbursement to the Monroe County Sheriff's Office School Resource Program, for the period of September 1, 2018 through June 30, 2019.

BOCES #1 will be provided a full-time Monroe County Sheriff's Office School Resource Officer ("SRO") during the 180-day school year, plus an additional 10 administrative days. The SRO's primary duty is to maintain an atmosphere where students, teachers and staff feel safe. The SRO may assist in the investigation of suspected criminal activity occurring on BOCES #1 property and/or related to BOCES #1. This assistance shall be provided in consultation with school administrators, in accordance with New York State Law and BOCES #1 policy. As an educator, working with classroom teachers and other BOCES #1 personnel, the SRO may present information and answer questions on a variety of topics, such as the law, drugs, safety, crime prevention, violence prevention, concepts of safety, traffic laws, general law, and crime prevention techniques. The goal of the presentations is to increase student, staff, and community awareness and understanding of laws and personal safety. The SRO shall also perform such other security and/or law enforcement services as may be reasonably assigned by the District Superintendent, in consultation with the Sheriff, as appropriate.

This will be the fifth year the Sheriff's Office has participated in the SRO Program at BOCES #1. BOCES #1 will fund the salary and fringes associated with the Sheriff's Office SRO assigned during the 180 day school year, plus an additional 10 administrative days.

The specific legislative action required is to authorize the County Executive, or her designee, to execute an intermunicipal agreement, and any amendments thereto, with Monroe #1 Board of Cooperative Educational Services, 41 O'Connor Road, Fairport, New York 14450, in the amount of \$96,424, for reimbursement to the Monroe County Sheriff's Office School Resource Program, for the period of September 1, 2018 through June 30, 2019.

Honorable Legislators:

I recommend that Your Honorable Body accept two grants from the New York State Department of Health, the first in the amount of \$35,714, for the period of April 1, 2017 through March 31, 2018, and the second in the amount of \$25,000, for the period of April 1, 2017 through March 31, 2018, both to support the Monroe County Nurse-Family Partnership Program (NFP).

The purpose of these two grants is to provide support of the County's existing NFP program. The NFP program is an evidence-based nurse home visiting program that has been rigorously evaluated and includes expertly trained nurses delivering the services per a standard curriculum. The grants will provide a portion of the funding for the NFP program, annually providing home visits to approximately 300 high-risk, first time mothers, their infants and families to improve their pregnancy outcomes and their health, well-being and self-sufficiency. The funds will be used to support existing positions, a previously authorized vendor contract, and administrative expenses to run the program. Even though the funding is from the same source, there are two separate legislative awards in the 2017-2018 State budget. This is the first year the County has received these grants.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept a \$35,714 grant from, and to execute a contract and any amendments thereto with, the New York State Department of Health, to support the Monroe County Nurse-Family Partnership Program, for the period of April 1, 2017 through March 31, 2018.
2. Authorize the County Executive, or her designee, to accept a \$25,000 grant from, and to execute a contract and any amendments thereto with, the New York State Department of Health, to support the Monroe County Nurse-Family Partnership Program, for the period of April 1, 2017 through March 31, 2018.

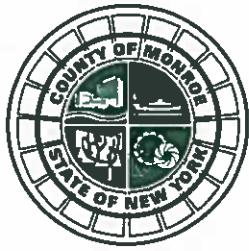

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from Health Research, Inc., in the amount of \$10,000, for the New York Violent Death Reporting System (NYVDRS) Program, for the period of September 1, 2017 through August 31, 2018.

The purpose of this grant is to establish a mechanism to reimburse the Monroe County Office of the Medical Examiner for the work associated with the preparation and transmission of data to the NYVDRS. The NYVDRS is a State level system that subsequently provides data to the National Violent Death Reporting System. 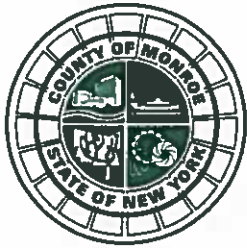

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Environmental Facilities Corporation, in the amount of \$150,000, for the State Septic System Replacement Program, for the period of March 1, 2018 through December 31, 2022.

The purpose of this grant is to provide Monroe County property owners with reimbursement of up to fifty percent (50%) of eligible costs, up to a maximum of \$10,000, incurred for eligible septic system replacement projects. In order to be eligible, the septic system is required to be in need of replacement or upgrade, and must be located within 250 feet of Irondequoit Bay (and minor tributaries), Mill Creek (and tributaries), and Shipbuilders Creek (and tributaries). This grant helps to provide the means to fix systems located near sensitive water bodies, thereby helping enhance water quality in Monroe County. Funds will be used to reimburse eligible property owners. The property owners will not receive the grant until after they have met eligibility requirements and the work is completed. This will be the first year the County has received this grant.

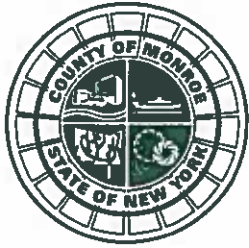

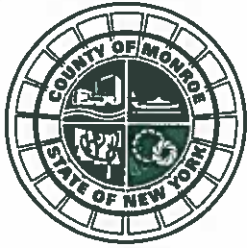

This matter is being referred to Your Honorable Body at the request of District Attorney Sandra Doorley and Sheriff Todd K. Baxter.

I recommend that Your Honorable Body accept a grant from the New York State Division of Criminal Justice Services, in the amount of \$1,213,609, for the District Attorney's Office, the Office of the Sheriff, and the Department of Public Safety, Office of Probation and Community Corrections, for the Gun Involved Violence Elimination (GIVE) Partnership, for the period of July 1, 2018 through June 30, 2019.

This project provides resources enabling the Monroe County law enforcement community to target violent criminals, and those possessing weapons, in a coordinated effort to reduce violent crime in Monroe County. The ultimate goal of this partnership is to support targeted firearm and violent crime reduction efforts within Monroe County. This is the fifth year the County has received this grant. This year's funding represents an increase of \$31,200 from last year.

Funds will be used specifically to help support the following programs in the following departments:

- District Attorney's Office:** Partially supports ten (10) existing Assistant District Attorney positions assigned to prosecute violent felons and criminals possessing illegal weapons, and to provide the Boys and Girls Clubs of Rochester, Inc. with a \$9,000 sub grant to continue its Project Step-Up Program;
- Sheriff's Office:** Supports an existing Sheriff's Criminal Investigator (50%), a Road Patrol Deputy (25%) and a Jail Deputy (100%), and underwrites part of the overtime costs of the Office of the Sheriff's participation in joint anti-crime efforts with the other GIVE agency partners;
- Office of Probation and Community Corrections:** Supports the cost of an existing Senior Probation Officer (100%), a Probation Officer for the Swift, Certain & Fair Program (100%), a Probation Officer for the Swift, Certain & Fair Program (50%), enhanced electronic monitoring (GPS) capability, and underwrites the overtime costs of the Office of Probation and Community Correction's participation in joint anti-crime efforts with the other GIVE agency partners.

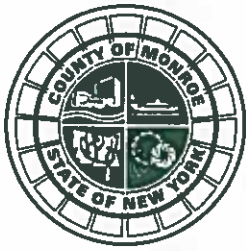
